Regarding the decision on environmental conditions for a project "Construction and operation of Poland's first Nuclear Power Plant, with an electrical capacity of up to 3,750 MWe, in the area of Choczewo, or Gniewino and Krokowa communes"

The Environment State Bureau (hereinafter – the Bureau) hereby acknowledges the receipt of the letter / announcement No DOOŚ-TSOOŚ.440.8.2015.69 dated on 6 of December 2023 (hereinafter – the Letter) regarding the decision issued on 19 September 2023 on environmental conditions for a project "Construction and operation of Poland's first Nuclear Power Plant, with an electrical capacity of up to 3,750 MWe, in the area of Choczewo, or Gniewino and Krokowa communes" (hereinafter – the Decision) in accordance with Article 6 of the Convention on Environmental Impact Assessment in a Transboundary Context on the 7th of December 2023².

The Bureau published the Letter on its webpage³ and send it directly to the competent authorities (the Ministry of Environmental Protection and Regional Development of the Republic of Latvia, the Ministry of Foreign Affairs of the Republic of Latvia and the Environment State Service) on the 8th of December 2023.

Please be informed that the Bureau has received opinions from mentioned authorities with reference to the first point of the note of the Decision⁴. According to the opinions received, the

⁴ "A party that is dissatisfied with this Decision may, in accordance with Article 127 § 3 of the Code of Administrative Procedure, apply to GDOŚ for re-examination of the case. An application for re-examination – pursuant to Article 129 § 2, in conjunction with Article 127 § 3 of the Code of Administrative Procedure – shall be filed within 14 days from the date of delivery of the Decision to the party".

Bureau confirms that the Republic of Latvia does not oppose the Decision and considers that there is no need to re-examine the case.
